## WHAT DOES THE APPRENTICESHIP ENTAIL?

As an Apprentice at Gordons, you will be employed by the firm full-time whilst studying one day a week with BPP University. The route to qualification as a Solicitor takes 6 years and during that time Gordons will pay you a salary, provide study leave and sponsor your training fees.

The apprenticeship is split into two parts:

- **Years 1-2** Paralegal Apprenticeship (includes BPP Level 4 Certificate in Higher Education)
- **Years 3-6** Solicitor Apprenticeship (includes LLB law degree and Solicitors Qualifying Exams)

On completion of all stages and passing all examinations and end point assessments you will qualify as Solicitor at the firm and hold a Level 7 qualification.

Our apprentices are supported and encouraged to specialise in a particular area of law. To be eligible you must:

- Be predicted to obtain or have gained 3 or more A levels at grade ABB or above in academic subjects this summer (conditional on grades being achieved). A-level equivalents will be considered.
- Have gained 5 GCSEs at grade 4 (C) or above, ideally in academic subjects including English and Mathematics
- Reside within easy travelling distance of our Leeds and Bradford offices
- Be available to attend the assessment days at our office in Leeds, which is part of the selection process
- Be hard working and ambitious
